Item 2 Minutes of Previous Meetings:

- 2.1 Minutes of the Management Committee Meeting held on 22nd May 2023

- **Item 3 Loan Portfolio** Committee approved the submission of the Loan Portfolio by the Finance Director to the Scottish Housing Regulator.
- IT Support Tender Committee approved the appointment of Stratiis as the new IT Support partner with a three-year contract commencing on 1st August 2023 at a cost of £40,870 (plus VAT) for the period of the contract.
- Heating Installation Tender Committee approved the appointment of City Technical Services (UK) to carry out the Gas Central Heating replacement works for the period 2023-26 in the sum of £2,108,133.72 (inclusive of 20% VAT).
- **Item 6 Update on Sheltered Housing Review** Following the presentation provided by the Housing Director the Management Committee considered and approved the Sheltered Housing Service Review, along with granting the Housing Director

permission to proceed with the consultation and implementation of the proposed changes to the service.

- Proposed Benefit to Staff (Salary Sacrifice Electric Car) The proposed staff benefit was approved by management committee. This benefit would be names the Salary Sacrifice Car Scheme and would be eligible to employees of the Association, albeit there will be criteria set out in the Association Salary Sacrifice Car Scheme policy to ensure responsibilities of the employer and the employee are clear and concise.
- Rent Arrears Report Committee noted that arears to end May 2023 reduced by £7501.03 to a total £190.6k with all cases being managed in line with policy and procedure. It was also mentioned that individual patches are being monitored in terms of arrears. This is to help identify any additional training or support need for specific members of staff.
- **Item 9 Governing Body Performance Review** Committee have been provided with sufficient information to enable them to decide on whether the two long-standing Committee members, who are required to stand down this year remain effective to stand for re-election at this year's AGM. Committee noted the report and are satisfied with the information within.
- **AGM Update** Committee noted the agenda/preparations for the AGM to be held on Tuesday 12th September, being a mix of online and in person participants. It was noted that those standing down and having confirmed their willingness to be reelected are, Andrea Bell, Steve Fleming, Theresa Findlay and Drew McPhail with three co-optees, John McMorrow, Gail Jackson and Sharon May seeking formal election.
- Item 11 Review of Customer Engagement Action Plan Committee noted that the CE Team lead members are now Managers Kenny McCoy, John McShane and Dianne Mathewson and they have all agreed to meet on 27th July 2023 with a view to refresh the action plan. This will be rolled out to PIN and Staff members for contribution and participation as necessary.
- **Item 12** Events Focus Group & PIN Update Committee noted the report issued providing an update of the activities recently arranged and undertaken by the Events Focus Group and the Performance Improvement Network. Committee were reminded of the following events:
 - **12.1** Easter 2023 The Events Group had agreed to offer a large easter egg at each site that would be awarded to those applying for membership via a prize draw.
 - **12.2** Summer 2023 The group had met and agreed to continue the annual bus trip which is going to Largs on 11th August. We are now offering £15 rather than £10 to tenants on the trip.
